10:00–11:30 **Session 2. Health and well-being; urban places, sustainability and the planet**

This session will focus on health and well-being as drivers for equitable and sustainable urban development. It will explore urban policies, planning and design that address two European cities' main challenges: tackling climate change and managing environmental resources including water and food.

This session will cover the role of people-centred policies to ensure equity, health and well-being are at the heart of urban environmental policies, and that cities are prepared for emerging health challenges such as aging and health security, through to the economic dimension, including the circular economy and economic governance of common goods and places.

This session will cover the role of social investment to ensure equity, health and well-being are at the heart of social urban development, including investing in health, early childhood development, education, culture and social services. It explores how city policies contribute to equitable community development and peaceful societies, as well as sustainable economic development through investment in human and social capital.
